Outbreak of foot and mouth disease in a herd of water buffaloes near Berlin

On Friday, the German authorities reported an outbreak of foot & mouth disease in three water buffalo out of a herd of 11 buffalo on the outskirts of Berlin.

It is not yet known how the infection started. No further cases have been reported.

Apart from South Korea and Vietnam, most Asian markets have already halted imports of pig meat from Germany due to the presence of African Swine Fever in the country.

South Korea opened its market to German pig meat in the summer 2023 following its acceptance of German regionalisation.



Rising exports of pig meat

The table below shows the official figures for Brazil's exports of fresh/frozen pig meat for 2024 compared with the two previous years.

As can be seen, at almost 1.2 million tonnes, Brazil's total pig meat exports ended 8.5 per cent higher than the same period last year and rose by 16.4 per cent compared to two years ago. The rise in exports in 2024 compared to last year occurred in the second half year as exports in the first half were on a par with the previous year.

Although there was a significant fall in exports to China and Hong Kong, this was more than offset by a rise in exports to a number of other export markets.

In terms of volume, exports to the Philippines in 2024 are on a par with exports to China, making the two countries the largest export markets for Brazilian pig meat. In addition to the Philippines, 2024 also saw a significant increase in Brazilian exports to Japan.

Mexico and the Dominican Republic are new markets which have opened up to Brazilian pig meat in recent years. The U.S. continues to be a substantial exporter of pig meat to these two markets.

ABPA expects a rise in exports of pig meat to Mexico

According to the Brazilian Animal Protein Association (ABPA), the renewal of Mexico's Anti-Inflation and Scarcity Package for 2025 means that Brazil's exports of pig meat to Mexico will continue to rise in 2025.

PACIC, whose purpose is to stabilise Mexican food prices, will ensure that tariff-free Mexican imports of a number of food products, including pig meat, can continue.

According to ABPA, total Brazilian exports of pig meat (including processed products) reached 1.35 million tonnes in 2024: a rise of 9.8 per cent compared to 2023. For 2025, ABPA expects total Brazilian pig meat exports to rise a further 7.4 per cent to 1.45 million tonnes.

Some weeks ago, ABPA stated that they expect Brazil's pig meat production in 2025 to rise by 2.5 per cent to 5.45 million tonnes.



USDA extends trial period for increased line speeds at pig slaughterhouses

The USDA has extended the period that allows a number of American slaughterhouses to operate at a higher line speed.

The extension applies until 15 May 2025 instead of 15 January 2025.

The National Pork Producers Council (NPPC) welcomes the decision and issued the following statement: "Pork producers appreciate USDA's thoughtful and thorough approach to maintaining increased packing capacity, giving us more opportunities to safely and more efficiently deliver our products to consumers."

The higher line speed trial began in March 2022. It allows certain slaughterhouses to operate at speeds that exceed the current maximum slaughter rate of 1,106 pigs per hour.

Under the Trump administration the speed limit was lifted, but a court decision in March 2021 decided that for safety reasons, a maximum limit should apply to the line speed at pig slaughterhouses.

The United Food and Commercial Workers (UFCW) support the maximum permitted line speed at slaughterhouses.

By contrast, the North American Meat Institute, which represents American slaughterhouses, previously warned that lower line speeds can reduce slaughtering capacity by 80,000 pigs per week and mean higher costs for slaughterhouses.
