POLAND

Poland believes the EU Commission has published its new ASF strategy too hastily

Agra Europe reports that Poland has accused the EU Commission for having published its new strategy for controlling African Swine Fever in the EU too hastily. As reported in last week's Market News, the new strategy was apparently unanimously approved by all EU Member States.

However, Poland claims that there has been insufficient time to go through the documents and that their views have not been properly taken into account.

As is shown in the table above, for the first time in many months, Poland has seen a number of cases of ASF at small pig farms – all close to the border with Belarus.

According to the Polish Minister for Agriculture, more effective control of ASF requires that the EU Commission does more to prevent the spread of infection via wild boars from Belarus, Ukraine and Russia.

The Polish authorities decided last week to implement more systematic culling of wild boar in the affected areas of Poland in an effort to reduce the population to a minimum.

Similarly, in Russia, plans are being made to systematically cull wild boar in order to create wild boar-free buffer zones at the border with neighbouring countries.

The EU Commission has so far been somewhat concerned about a strategy of systematic culling in the buffer areas as it is feared that this will only drive the animals into new areas.



Pig meat exports

The EU Commission has published preliminary figures for EU pig meat exports (measured in slaughter weight) for the period January-April 2017 compared to the same period last year.

As is shown in the table above, there is a substantial reduction in exports to China. For the period Jan-March 2017, exports to China were on a par with the previous year.



Court approves the sale of Financière Turenne Lafayettes meat processing activities to Cooperl International news media report that a court in Paris has approved the sale of the French food group, Financière Turenne Lafayette's meat processing activities to Cooperl.

As a result of the deal, which includes 1,600 employees, Cooperl will acquire a number of well-known brands such as William Saurin, Garbit, Madrange, Le Foué de Paul Prédault, etc.

The Breton Cooperl Arc Atlantique is France's largest pig processor. France's second largest pig processor, Bigard-Socopa, also made a bid for the failing Lafayette's meat processing activities.





Russia almost self-sufficient in pork and poultry

The Pig Site reports that during his Direct Line TV broadcast, Putin said that Russia is now almost self-sufficient in pork and poultry, thanks to anti-Russian sanctions.

The Russian President singled out pork and poultry as examples of industries where sanctions have had a positive impact on Russian production. He added that Russia is now looking for markets for meat exports, including China.



Visit from Japan

Pig333 reports that representatives from Japan's Ministry of Agriculture have visited Russia. The visit was arranged by the two countries' veterinary authorities.

The purpose is to give the Japanese representatives an insight into conditions in Russia in terms of Foot & Mouth disease, Classical Swine Fever and African Swine Fever with a view to possible future Russian exports of pig meat to Japan.



Ministry of Agriculture to limit pig production closures

In an effort to limit unfair pig production closures, China's Ministry of Agriculture last week issued new guidelines for interpreting the rules on pollution control by livestock producers, reports The Pig Site.

According to the Deputy Minister of Agriculture, Yu Kangzhen, many local authorities have over-implemented the current regulations and have shut down as many pig productions as possible without taking into account the substantial losses for local producers.

The Gaoan district in Jiangxi province, for example, is one of the 100 largest production areas where 4,760 productions have been shut down since October. In 2017, the local authorities extended the area where pig production is banned, which means a further 1.726 pig farms have been closed.

According to Yu, the new guidelines will prohibit local authorities from employing extreme tactics to limit pollution. Pig producers in the selected areas must be assured of a transitional period rather than simply being closed down.

Moreover, Yu has called for reasonable compensation for producers who have to close or move their production. However, the new guidelines give no details about any compensation.



Wens to invest in COFCO Capital

Reuters reports that China's largest livestock producer, Guangdong Wens Foodstuff Group, is planning to invest between 800-1,000 milion yuan (USD 118-147 million) in COFCO Capital.

In April, the state-owned COFCO announced that COFCO Capital was seeking to raise 8 billion yuan, including 2 billion yuan from new shareholders.

COFCO is currently restructuring its business, including listing a number of its companies.

Final agreement on American beef to China

Last week, the US Department of Agriculture announced that it had finally concluded an agreement with China, which means that US beef can be exported to China once again. American beef has been excluded from the Chinese market since 2003.

The agreement means, however, that China will only accept beef free of growth promoters, feed additives and chemical compounds, including ractopamine.

The Chinese ban on ractopamine in meat means that the American beef industry – as is the case with pork – has to establish a system of ractopamine-free plants.

US beef exports to China are expected to resume from mid-July from a limited number of companies.



NAFTA agriculture ministers to meet this week

Reuters news agency reports that the agriculture ministers from USA, Canada and Mexico will meet this week to begin talks on renegotiating the North American Free Trade Agreement (NAFTA).

The three ministers are meeting in Georgia, Sonny Perdue, the U.S. Agriculture Secretary's home state.



NPPC welcomes Trump's environmental policy

The National Pork Producers Council (NPPC) welcomes the stand being taken by President Trump on environmental rules that impact U.S. agriculture.

NPPC's Assistant Vice-President Michael Formica says that Trump has done two important things:

First, Trump has said that agencies can only introduce a new regulation if they remove two. According to Formica, there are a plethora of rules that are now outdated.

Secondly, Trump has ordered the Environmental Protection Agency to look at the Waters of the United States rule to see if it can be repealed, amended or retained. Michael Formica expects to see changes as a result.



Changes at JBS

JBS has appointed Gilberto Xandó to its board to replace Chairman Joesley Batista, who resigned last month. Gilberto Xandó is the chief executive of dairy company, Fábrica de Produtos Alimenticos Vigor SA, which is controlled by JBS parent company, J&F Investimentos.

In an effort to address the company's poor image, JBS has appointed lawyer Marcelo Proenca as global head of compliance. The law firm, White & Case LLC, will also help oversee the creation of the new global compliance unit. Proenca has a PhD in Law and has 27 years experience in company and commercial law.

Marcelo Proenca will implement structures to monitor compliance and other procedures across JBS' different units internally and externally. His new department will report directly to the board of directors.

The changes at JBS follow in the wake of the owners of JBS agreeing to pay a fine of R\$ 10.3 billion (\$3.1 billion) over 25 years.
